Please include **1.** your completed application, **2.** your resume/curriculum vitae (CV), and **3.** your personal statement. Each area listed above will be scored according to the attached rubric. The rubric is scholarship committee use only.

Your resume/CV should include your academic (include GPA and class rank), employment/community service, awards and extra-curricular data.

Your personal statement is where you tell us “why you deserve the MABAH scholarship.” We are reviewing for content and structure, i.e., what you write and how well you write it. Include your strengths as a law student, how your law degree will assist in meeting your goals and community service in the Hispanic community, including MABAH if applicable. The hardship aspect (see rubric), or what you’ve had to overcome in pursuing your education, should be included in your personal statement. This is not the topic of your personal statement, but should be one part of our personal statement, if applicable to your situation.

This a blind application review and no person reviewing your application will see your name, or other demographics that could create a bias in the review process.

Three law students (1L, 2L, 3L) from each of the Houston Area law schools will be awarded with scholarships in the amount of \$1,000.00 each. The scholarship recipients will be presented their scholarship awards at the 2026 Hispanic & Latinx Law Students Associations' Scholarship Gala on March 27, 2026.
